

Camper Code of Conduct 2020

This code is in effect July 17, 2020.

Campers,

Please read this Code of Conduct and review it with all family members. The rules in this Code must be followed to ensure we all stay safe and do not engage in activities that contravene any Provincial or Federal Government regulations and ensure we comply with all health regulations. This Code is over and above our normal campground rules, which still apply. Strict enforcement of all rules will be in place for all registered names on your occupancy agreement and any visitors that you may have. **Any camper, regardless of age who breaches this Code will be asked to leave the campground immediately.**

At this time, we will be operating under the following rules. These rules may change as the Ontario or Federal Government amends legislation.

Campers

Only one family/household can be registered per site. Campers must park their trailers on the sites as they are laid out to be parked (no parking in circles or backwards to be with friends)

Visitors

You will now be permitted to have visitors. The registered camper is responsible for their visitors. Please remember to practice physical distancing from your visitors who do not live in the same household as you.

Common Areas

The following common areas are closed until further notice. All areas that are closed are indicated with caution tape. If you are unsure whether something is closed or not, please contact the office.

- Rec Hall & Pavilion

Office/Store

Please see below for the complete rules of how our store is operating.

- The store will continue to be open for window pick-up as well as open for campers to walk in
- Face masks must be worn by anyone who walks into our camp store as per city bylaw
- Only 1 person/family will be allowed in the store at one time
- Hand sanitize upon entering the store
- Only touch what you plan to buy

Camp Events

- All camp events are cancelled until further notice

Playgrounds & Recreational Areas

- Use at own risk
- Please wash/sanitize your hands before and after using any equipment
- Parents will be responsible for ensuring their children are physical distancing while playing on equipment

Walking Around Campground

- At all times campers must obey physical distancing rules as mandated by the Province of Ontario. Currently, you must stay 2 meters or 6 feet away from other campers.

Pool

- There will be a ONE direction flow around the pool deck. There will be arrows posted on the fence of the pool to keep the traffic flowing in the same direction.
- We will not be providing any seating in the pool area.
- Please ensure physical distancing when in the pool and on the pool deck. The fence posts will represent the 2m spacing where you will be able to sit or stand at a safe distance from your neighbour.
- There will be a limited amount of people permitted in the pool area at a time. Please respect others in the park to allow others the opportunity to use the pool as well.
- If you are not swimming or supervising, please sit outside of the pool enclosure.
- During busy pool times please respect the ½ hour time limit to allow everyone to have an opportunity to use the pool.

Respect of others and staff

All Customers, guests and staff are responsible for respecting the dignity and rights of everyone at the campground. Every person has a right to expect their time at the campground will be without any type of discrimination or harassment. We will not tolerate, ignore, or condone discrimination or harassment and we are committed to promoting respectful conduct, tolerance and diversity at all times.

I, and all of those registered to my site, agree that:

- I will not enter the campground if:
 - I am currently experiencing COVID-19 symptoms, or have experienced COVID-19 symptoms in the past 14 days
 - If you have tested positive or are a presumptive case.
 - I have travelled outside of Canada in the past 14 days
 - I have provided care or had close contact with any person with COVID-19 or with any person who has travelled out of the country in the past 14 days
- **I will respect physical distancing measures and stay at least 2 meters apart from all people not in my immediate family (i.e. no large group gatherings/group campfires, etc.)**
- I will respect all measures not explicitly stated in this agreement that Local Health Units and all levels of government put into place before and after the signing of this agreement with respect to COVID-19.

Anyone found not adhering to any of the above restrictions will be asked to leave the premises immediately.
